What a fine collaboration! Oceanside Conservation Trust (OCT) and Peaks Island Land Preserve (PILP) have been working together on Peaks Island since 1995. This relationship has involved mentoring, cross membership, and double layering strategies leading to maximum protection of these special places. Much of this work has been done quietly, without public promotion. But now, this summer, these two organizations have an opportunity to show off more tangible, visual evidence of their collaboration. The Ice Pond, with such a rich and valuable history of over a century, will be having its dam rebuilt. Join us on August 1st to watch, but stay out of the way when it is being drained!

Oceanside, however, began its history of conserving island lands in 1982. Earlier on, Project Oceanside had been formed out of a visionary desire to make good things happen with the military leavings on Peaks. When CBIDA was formed as a next step, to include other islands, OCT was carved out, given

a small amount of Peaks land, a modest amount of funding and a charge to address and implement conservation around Casco Bay.

To this purpose, each year's issue of our colorful and informative Newsletter has kept you abreast of what we have indeed accomplished. It continues to be a compendium of highlights, events, locations of conserved parcels, and peeks at the thoughtful and energetic folks behind these decades of steady work.

What these issues do not provide are lists of our donors.
