
## Monitoring all 14 of OCT's property responsibilities











The Gardiner Parcel

ocated along the southeasterly shore of Cliff Island, the Gardiner parcel offers a beautiful view of the channel between Cliff and Jewell islands. Some years ago the land was donated by David Gardiner to Cliff Island Corporation for Athletics, Conservation and Education (ACE). Oceanside now holds a conservation easement on it. This easement is a step toward more conserved land in the interior of Cliff Island.






Abutting a shingle beach, this small parcel is covered with ferns and a modest scattering of red spruce. These hardy trees have so far survived the massive blow downs that have significantly changed the surrounding landscape.

Oceanside Conservations Trust's conservation easement allows low-impact recreation such as hiking, birding, and enjoying the beautiful views.

## Annual Meeting on Cushings Island

ceanside Conservation Trust of Casco Bay's thirty-second Annual Meeting was on Cushings Island on August 4, hosted by Cushings Islander and OCT Board member John Spencer. The theme of the meeting was stewardship, a core capability and strategic priority of OCT.







The meeting combined a tour of conserved land on Cushings led by John Spencer, who is also the current President of Cushings Island Conservation Corporation (CICC), with a keynote address by Jane Arbuckle, Director of Stewardship with the Maine Coast Heritage Trust (MCHT).

John's tour showed how CICC is managing about 142 acres that include wetlands, woodlots, open fields and overgrown pasture. Cushings Island has a significant amount of invasive plants, and the tour highlighted how CICC is managing areas recently cleared of honeysuckle and bittersweet. The tour also stopped at the evergreen woodlot damaged by a severe winter storm in February 2010 with a discussion on how CICC is monitoring the reforestation process. John emphasized the importance of having even a simple land management plan, and how lucky Cushings is to have a group of active islanders who volunteer to help maintain restored areas. Jane Arbuckle's address summarized the much larger-scale efforts of MCHT to steward more than 150 conservation easements and more than 50 preserves along the Maine coast. She reviewed the many factors that go into MCHT's stewardship program. She noted that much of that effort depends upon effective outreach to communities, dealing not only with how best to manage the land but also how to maintain relationships with the people who use or are neighbors of protected areas.

Sunny weather and a chance for OCT members to revisit Cushings resulted in a strong turnout – close to 100, with representation from all the neighboring islands in Casco Bay where OCT has properties. OCT president Roger Berle led the business meeting where he reinforced John's and Jane's stewardship messages. Work similar to that on Cushings and on MCHT properties is being done successfully on other islands as well.














Thanks to Roger's leadership, OCT resources are being leveraged and expanded through the Southern Maine Conservation Collaborative. While OCT is a leader in local conservation efforts, Roger reminded everyone about the importance of the generous support OCT has had from those who want to see conserved lands cared for appropriately.

Seeing the work done on Cushings, listening to Jane Arbuckle, great weather, and talking to so many from our island communities made for a successful meeting. As four boat trips took all back home, OCT hoped the message on conservation will spread and take even deeper root as we collectively deal with the future of our unique part of the world.









## Oceanside's Financial Collaboration


hrough the generosity of Oceanside's membership and healthy returns over the past several years on its investments, Oceanside is able to help other organizations preserve land in Casco Bay, and to maintain sufficient funds to serve as good stewards for its land interests (both in fee and in easement), as well as to protect and defend these assets from any future legal challenges. From time to time, Oceanside utilizes these reserves to provide financial support to other organizations' conservation efforts. By collaborating with other organizations on efforts that are consistent with Oceanside's organizational mission, Oceanside can help achieve goals that would be unreachable by any local land trust acting alone.



Three exciting examples of such collaborative work have already occurred this year.

Earlier this year, we supported the Peaks Island Land Preserve's purchase of the island's ice pond, which also serves as a fire pond for the northeast portion of the island. The parcel has now been purchased and PILP awaits an engineering study to determine the need to rebuild the dam creating the pond. The Portland Land Bank has also pitched in with significant support.

We made a contribution to the Maine Coast Heritage Trust Clapboard Island preservation campaign. Clapboard Island, just off the Falmouth shore, now has fifteen acres



of wooded, shorefront land and lovely trails newly preserved in perpetuity by Maine Coast Heritage Trust. Our modest donation may have been a drop in the bucket of a \$1,600,000 campaign, but we feel good about kicking in on a neighboring effort.

In April we made a contribution to the Francis Small Heritage Trust to help finance its legal fees in challenging a ruling by the Town of Limington that the tiny, all-volunteer land trust was not entitled to a property tax exemption as a "benevolent and charitable institution." Over the years, the FSHT has saved from development fourteen hundred acres amid the Sawyer Mountain Range, and Limington believed it should be permitted to tax FSHT on its holdings. The FSHT appealed the town's decision all the way up to Maine's highest court. We are happy to report that in August Maine's Supreme Court issued a landmark decision in the case, ruling that land conservation is indeed a charitable purpose and that typical land trusts in Maine are eligible for property tax exemptions on their holdings. The ruling is a significant victory for land trusts and land conservation efforts all over the state.

## GREAT NEWS for all Maine Land Trusts

Maine Coast Heritage Trust reported in August on the following Maine Supreme Court decision:

"It is time to directly declare that a legitimate land trust, such as this one (The Francis Small Heritage Trust), which meets the statutory and case law requirements, is a benevolent and charitable institution exempt from local property taxes. The direct and indirect value of open space preservation particularly when, in appropriate cases, it is coupled with access for a wide variety of recreational activity is within any modern definition of a charitable institution. In addition to the ecological and environmental benefit of land preservation there are numerous physical, psychological and, for some, even spiritual benefits to having access to undeveloped land."


## HONORING the MEMORY of AJ ALVES


